TERMS AND CONDITIONS

1. Clay's Park Resort maintains the right to approve all applicants; your application will be reviewed for final vendor selection.
2. Vendor must meet all Health and Safety requirements (included or attached) for Canal Fulton & Lawrence Township and possess a valid Vendor's License.
3. Vendor's license must be displayed during the course of the event.
4. Vendor must have Liability Insurance, and food vendors must provide an Insurance Certificate that names Clay's Park as additional insured. This is due ten days prior to the event at our Corporate Office.
5. Water and Electrical Hook-ups, Tables and Chairs may be rented from Clay's Park for an additional fee and must stay within the confines of the 10' X 10' booth space.
6. No food or beverage may be sold by a non-food vendor.

Special Instructions for Food Vendors:

7. All food must be protected from contamination and stored in approved, sealed containers.
8. Under no circumstances, should persons with colds, flu, skin infections or health problems prepare or serve food!
9. No smoking is permitted in the vendor tent or while preparing, handling, and serving food.
10. Persons handling food must use disposable gloves and meet all food handling requirements of the Stark County Health Department.
11. Food Vendor must supply adequate supply of paper and plastic products for its own customers.
12. Food Vendor must supply adequate supply of food and back up supplies to meet festival demands.
13. Vendors must store refuse in covered, moisture resistant containers. Absolutely NO GREASE is to be dumped on the property.
14. Food Vendor must bring an approved, fully charged Fire Extinguisher, and have a current authorized inspection tag.
15. Propane tanks are not to be stored in trailers or trucks and must be kept away from open, flammable devices.
16. Both parties agree that the vendor is contracted as a self-employed, independent contractor and is not an employee of the park.
17. Vendor shall hold harmless, Clay's Park Resort, its agents and all sponsors involved, for any loss, injury, theft and damage.
